Cdk2 is placed below Cul3-KLHL20. Hypoxia points Cdk2 and Cdk2 inhibits PML.

The error:

6. IFN→PML→STAT1-|angiogenesis [110],

Should instead read:

6. IFN→PML→STAT1-langiogenesis [110]

STAT3

STAT3 is placed below STAT1. PML inhibits STAT3 and STAT3 points angiogenesis.
